Dear Quilting Sisters,

Wow! March was certainly a busy month for the Fallbrook Quilt Guild. As we gear up for the transition into a new guild year 2016-2017, your nomination chairs, Barb Vajda and Lou Cobb have been beating the bushes in search of guild members willing to serve their guild. They certainly deserve lots of applause for their efforts. Barb Vajda volunteered for nomination responsibilities, in addition to being our current Treasurer, AND while working a full-time job! Lou Cobb, our current 2nd VP and a phenomenal multi-tasker, assisted while doing Grandma duty in England! Barb and Lou, you ladies are Super Stars!

Starting off March 1st, our guild has a display at the Fallbrook Chamber of Commerce promoting the diversity of quilts. The five quilts, on display for three months at the Chamber office on Main Street, show traditional pieced quilting, paper piecing, hand applique, a whimsical art quilt, and a bead/metallic thread-embellished quilt. Marie Sundsboe and Sandy Scott allowed me to recruit them for hanging those quilts. Sandy was so brave to climb the ladder and hanging one of the quilts at a height of 10 feet! Marie and I did our part—we held the ladder for her! Be sure to stop by to see this display. Our Chamber membership provides many opportunities for advertising and community involvement.

March was especially exciting for members anticipating the lecture and free-motion quilting workshop presented by Sharon Schamber, quilter extraordinaire. Sharon was a delightful speaker, her quilts were beyond breathtaking, and her workshop was jam-packed with information, instruction, good humor, and aura reading. Many thanks go out to Marie Sundsboe and Sandy Scott, who handled all the transportation, entertainment, lodging/meals, and lecture/workshop setup/takedown for our gifted speaker. Thank you, Marie and Sandy, for stepping up to the plate to plan and coordinate everything!

Our Quilts of Love committee collected 22 quilts from our generous members at our March meeting, and Floyce Royer reported that she delivered 19 quilts to the hospital on Camp Pendleton. An additional six quilts are soon to be delivered to birth mothers giving their babies a better life through the Adoption Center of San Diego. Whether you made quilts for babies born to our military personnel, or for birth mothers giving up their babies for adoption, each quilt s special because it is stitched with love, caring, and compassion. Thank you so much for your generosity!

Our gorgeous Opportunity Quilt 'Words to Live By' continues to bring in the ticket sales, with Ways & Means team members, Susie Alderson and Jan Conklin worked hard at selling tickets during the March Quilt Run. Even though the revenue goal is getting closer, there are STILL members who have either not paid for their tickets, or who have not paid the full amount. What's up with that? Part of being a member in good standing requires the purchase of 30 raffle tickets. Members have the option of keeping the tickets for themselves or selling the tickets to others. Please be sure you are a member in good standing. Thank you team Ways & Means for the fantastic job you are doing!

A REFLECTION ON THIS OLD QUILT

I was probably just as much in awe of Sharon Schamber's incredible artistry as the rest of you when she showed masterpiece after masterpiece at our March guild meeting. I would love to be able to create quilts that truly are such works of art but, you know how it is, life gets in the way sometimes. And, after seeing yet another birthday come and go just a few weeks ago, I was even feeling slightly discouraged accepting that there just enough time lifetime left to achieve Sharon's degree of creative artistry. But, then I read the following reflection my sweet (and so very talented!) niece posted on Facebook, and I felt genuine gratitude

for the ability to create any quilts at all. Let me share her musings with you...

As I've been sidelined for a few days waiting for this sickness to pass, I've been reflecting on this old tattered, faded quilt. It was my first attempt, made at the ripe old age of 17, for the man who would become my husband. I had no idea there was such a thing as a rotary cutter, so I tore the fabrics into strips. I had no knowledge of binding or actual quilting, so it was simply finished and tied. If I'd know at the time the things this quilt would see, I'd have shaken my head in disbelief. In its youth, the browns were rich and earthy, the blues bright, like shades of new denim and the border a soft, fine wale corduroy in chocolate brown. Through the years, it has protected soft baby legs from grass at the park. It has hosted countless picnics, served as a source of warmth during backyard campouts, become an indoor fort. It has comforted sick children, been puked on, sneezed on, fevered on, and as a result, taken many trips through the wash. It's seen a husband through cancer and a daughter through Mono. Poor thing is so faded; the corduroy is completely worn through in spots and has been many times repaired. A few times I've considered retiring it, only to be met with pleas to let it stay. This old rag will be with us to the end. It will soon get a new binding made from the old jeans of the man it was made for. I hope to be loved this much when I'm old and soft and worn.

GENERAL MEETING MINUTES

Call to Order: A general membership meeting of the FQG was held at the Fallbrook Community Center in Fallbrook, Ca., on Mar. 3, 2016. The meeting was convened at 6:30 PM, by our presiding President Shirley Fleming, who led the Pledge of Allegiance.

President's Announcements:

- Welcome to tonight's guest speaker Sharon Schamber, who has a treasure of beautiful quilts to share with us. Thank you to both Marie Sundsboe and Sandy Scott for all the arrangements for Sharon's visit, and a special thank you to Sandy for opening her home to Sharon during her stay.
- Minutes of the Feb. guild and board meeting were reviewed, approved and published in the last newsletter. Our next board meeting will be on Mar. 11, 2016 at 10a.m. Our board meeting this month will be held at Jessie Lee's home.
- The Feb. newsletter required much patience on the part of our editor, Christy Smith. Please show your appreciation for the outstanding work that Christy has done with our newsletter both last year and this year. In addition, we are still in need of someone to take over as editor for next year. If you are interested, please see Barb Vajda or Lou Cobb.
- Our guild is a member of the Fallbrook Chamber of Commerce. Benefits to us are: inclusion in brochures distributed by the Chamber; extra advertising of our special events. Since the last board meeting we were asked to put together a special display of guilts to hang at the CofC.
- Members that contributed quilts for this display include: Sandy Scott, Barb Anderson, Shirley Fleming, and Ann Turley. The display includes a traditionally pieced quilt, a hand appliqued quilt, an art quilt. A bead-embellished quilt, and a face quilt, in order to illustrate the great variety of quilts, and to encourage new membership. The title of the display is "Diversity of Quilting". To promote our 2017 Quilt Show, Sandy has already reserved the months of Aug., Sept., and Oct. 2017 to display quilts and advertise the show. We are also working a special flyer and new business cards to put out at the CofC, and want to create a trifold brochure.
- Additional benefits of belonging to the CofC includes free seminars. On Feb. 29th Marie Sundsboe, Shirley Fleming and Sandy Scott attended a State Board of Equalization seminar on Non-profit organizations and sales use tax. Seminar was very enlightening, and informative. We are very fortunate that Marie is very well versed in this area.
- At the Feb. board meeting, the board position of Non-Profit Compliance Officer (NPCO) was approved with Marie Sundsboe nominated for the position, which will begin with our new year.
 This is a 2-yr. position, responsible for keeping our guild in compliance with all Federal, State, and local requirements in order to maintain our legal Non-profit status. Marie will be voted into this position in May, along with the rest of the other Board members. Until then she will continue her role unofficially acting as our NPCO. Many thanks to both Marie and Rosalie Mikelson for working so diligently since 2012 to bring our guild into compliance.
- Please read your most recent newsletter to review the proposed by-law changes for the creation of the Non-Profit Compliance Officer position, as well as the wording changes to the by-law regarding our scholarship. We will be voting on these issues in April.
- The SCCQG meeting on April 9th will be "Meet the Teachers" This will be a wonderful opportunity for our new 2nd VP, which we still need someone to fill the position, to meet potential speakers for the new year. If you are interested in going please see me to reserve your seat.

Treasurer (Barb Vajda): Our current bank balance is \$33,867. Dec. income was \$524., and Dec. expenses were \$239.

Nominating Committee (Barb Vajda and Lou Cobb): still looking for members interested in serving on the board or a committee for next year. There are forms at the table by the entry door to fill out and turn in if you are interested.

Membership (Ardis Duhachek/Diana Rash): we have 71 members signed in, 1 new member, and 7 guests, this evening. We have a total of 112 guild members.

Ways and Means (Jan Conklin): thanks to all that helped out with white gloving and ticket sales at Road.

We sold \$238 in Opportunity Quilt tickets at the show.

Hospitality (Tuesday Girls): thanks to everyone that brought food tonight. We still need volunteers for food for both March and May.

Scholarship (Betty Hall): applicant must be from the area. We have \$1500 in scholarship monies available. Scholarship application is on our website, and all schools in the area have received applications as well.

Shop & Swap (Paula Manning): thanks to everyone that brought things in tonight for our 1st shop and swap. You can bring in things that you no longer need or want to put out for sell. If your things do not sell, please take them home and bring in again at another meeting.

Programs and Workshops:

March: Sharon Schamber presenting a Trunk show at the meeting and her workshop on March 5th will be "Machine Quilting on a Domestic Machine."

April- Irene Althaus will be presenting our program on Chicken Linens. No workshop.

May- Claudia Gomez will be presenting "Motion is Lotion" at the meeting and her workshop on May 5th will be "The French Door Wall Hanging."

Tonight's speaker is Jill Rixman, presenting "The Evolution of a Pattern Design".

BOARD MEETING MINUTES

March 11, 2016

Call to Order: An Executive Board/Committee Chair Meeting of the F.Q.G. was held at the home of Jessie Lee, in Fallbrook CA. The meeting was convened at 10:04 A.M. Presiding was President Shirley Fleming. Members present were Barb Vajda, Cheryl Jeter, Marie Sundsboe, Dawn Johnson, Diana Rash, Ardis Duhachek, Lou Cobb, Sandy Scott and Jan Conklin.

Committee Reports:

Treasurer's Report (Barbara Vajda): Mar. income was \$747.50, expenses were \$1890.60. Current balance is \$32,875.40.

Barb has added a "Sales tax Payable" to the Treasurer's Report. Marie will track all sales tax that we pay from our special events and report them to Barb.

Membership (Ardis Duhachek, Diana Rash): discussion on how to handle a situation with two former members that attended the March meeting and did not sign in as guests or pay the guest fee. One of the former members wore her guild badge and then participated in Show and Tell. Lou suggested that both ladies be sent a bill, Marie suggested that a letter be written to them. Shirley will be writing a letter to each former member concerning the situation and advising them that we aware of them attending as non-members, and not paying guest fees. It was then decided that if the situation then occurs again after the letters are sent, then membership is to advise Shirley and she will address them at the meeting.

Ways and Means (Jan Conklin): Susie Alderson and Jan Conklin sold Opportunity Quilt tickets at the Cottage over two weekends, selling \$200. In tickets. Jan said that the theme of the Quilt Run was western, so on Sat. when she was selling tickets she dressed in a western theme and found that her sales increased significantly, especially with men coming in to purchase tickets.

Still have a number of members that have not paid for tickets picked up, or still owe a balance of \$5. Still have a few members that have not picked up their tickets, as well. Discussion on whether tickets should be numbered. It will be less expensive to print tickets without being numbered. We have sold 4,217 Opportunity Quilt tickets to date, so that by June we should have sold all 5,000 that were printed, plus some additional tickets that Jan has printed off her home printer.

The Board agreed that going forward that all tickets will be paid for in full at the time they are picked up and the member must sign for them at the time of pickup. Diana Rash suggested that we put a reminder on the member application reminding everyone that members are expected to sell Opportunity Quilt tickets and complete 2 Quilts of Love ea. year. Sandy will add this to the application form.

Jan brought up the situation of not knowing which past presidents are no longer active in the guild and those that should be purchasing Opportunity tickets. Suggested that going forward that past presidents that are no longer active being noted in the directory. Shirley will contact any active past presidents that have not purchased their tickets or this year and remind them of their obligation to still sell Opportunity Quilt tickets.

Jan is still trying to get in touch with someone from the El Camino Guild to see if they will allow us to display our Opportunity Quilt at their upcoming show in April.

Newsletter (Shirley for Christy Smith): articles for the March newsletter need to be to Christy by March 21st. It was suggested that we add technique articles to the newsletter for our new members. Lou suggested that we start this in the summer to coincide with "Quilt University" which she has planned for the Aug. meeting/workshop. Question came up as to whether or not we can copy published articles, due to copyright issues. This will be checked on, but it was also suggested that the information could be reconfigured, or that we could add links to websites, that will take members to the info.

Boutique (Lou Cobb): there will be no boutique booth at Myrtle Creek for Mother's Day. There is an event at the end of the month, and Lou will advise Jan Conklin of the dates as a possibility to show the Opportunity Quilt. Jan suggested an alternative event for the boutique for Mother's Day – Primitive Antiques, in Old Town Murrieta. Lou was interested in this suggestion, so Jan will forward info to Lou about it.

Marie advised Lou that she needs to know of all Boutique events in advance in order to apply to the state for a sales tax license for each event.

Nominations (Barb Vajda and Lou Cobb): reviewed the list of nominations with board, those who have accepted a position and those that are considering a position for 2016-2017. Still trying to fill the following positions: secretary, block of the month, friendship groups. It was decided to eliminate the positions of historian, advertising and librarian. Shirley will be talking to Paula about taking a small amount of books from the library collection we have and selling them in the Shop and Swap ea. month. Those books that do not sell can be taken to the library. There is a video of our 1st quilt show that is in the library that needs to be kept out. The nominations for the new board and committees will be presented to the guild at the April meeting, and voted on at the May meeting. Jan Conklin suggested that a list of nominees be made up and pasted out at the April meeting.

Bylaw Changes (Shirley Fleming): Voting on by law changes will be held at the April meeting.

Workshops for 2016-2017 (Lou Cobb): Lou reviewed the programs and workshops that she has planned for the new year. She will be presenting this info to the guild at the May meeting, along with when members can start signing up for the workshops. Lou presented

an example of a tri-fold brochure that she wants to print up listing the workshops for next year. This will be a colored brochure showing an image of the workshop project along with a workshop description. Lou said she has budget to print the brochure. Shirley suggested that possibly some funds could come from the advertising/publicity budget as well. It was suggested that we print a larger number of the brochures, so that they can be placed at the Chamber of Commerce and the Historical Society. The board approved to have the brochure printed in time to have at the May meeting.

Marie noted that while Lou has been 2nd VP that she has gone through all past records and created a spreadsheet of all past speakers.

This info will be on a USB drive that will pasted along to the new 2nd VP.

Quilt Buddy Committee (Shirley Fleming): Shirley had discussed this position with Tiffany Ortega last fall. She will follow up with Tiffany to see if she will start for the new year, as well as take on the Friendship Group committee.

Misc.

Quilts of Love labels – need to have new labels printed. Shirley presented a quote. Sandy told Shirley she has other sources that were less expensive, and will forward the list to her. It was decided that the labels should be printed and not embroidered.

Quilts for Birth Mothers – Shirley now has 6 quilts and will arrange a time to deliver them.

Filed Trip: Diana Rash suggested doing a field trip Hoffman Fabrics.

Volunteer List: Jan Conklin suggested that we have a list of volunteers that can be called on to help out at guild functions. It was suggested that we put the list of "Areas of Interest" back on the members' application form

WAYS AND MEANS STILL SELLIN' THOSE TICKETS!


