As you know, you are not required to buy a specific amount of tickets as part of your membership, but we need everyone to pitch in, that's what makes our guild strong. Here are a couple of ideas:

- 1. Commit to buy a few tickets each month.
- 2. Sell tickets to your neighbors, dentist, hairdresser, manicurist, or store clerk. We've all given these folks lots of our money over the years. No need to make an extra trip, you're going there anyway.
- 3. We all have those neighbors and friends that we always support, Girl Scout cookies, local high school sports, well it's payback time. While they are selling something to you, what a great opportunity to sell them.
- 4. Set up a table at an organization you belong to, such as a garden club, art association, or religious group and sell tickets. Ask Ways and Means if you can display the guilt at your event.
- 5. Sell tickets to those pesky door-to-door sales people. Turn around is fair play good way to end their sales pitch. Be sure to keep some tickets by your front door.

The member who sells the most ticket will win a miniature quilt - that includes what you buy. If you volunteer to sell tickets at a Ways and Means organized event, ticket sales credit is divvied between the individuals working the event. Only tickets provided by the Ways and Means Committee will be sold at events organized by the Committee. Members will not permitted to sell their own tickets at these events.

It would be so great if we could raise enough money to partially finance a trip to a quilt show or participate as a group in a quilt run. Are there any excursion coordinators out there?

Tip: When I purchase sheets they come in this great plastic bag that has a zipper. Ah Ha moment – I can but my quilt tops that need to be quilted and I can see them through the plastic. Best of all, it was free ... well sort of.

The drawing for the "Flowers in the Night" opportunity quilt will be held at our next meeting, August 7, 2014. The Executive Board is scheduled to meet at Quilter's Cottage on Friday, August 8, 2014, at 10:00. Guests and members are welcome to attend.

# **UFO CHALLENGE**

Are you ready to get some of those UFOs behind you? Do you want to rid yourself of the guilt of non-completion? YES? Then let's do the UFO CHALLENGE!!!! It's very simple and anyone with UFOs can play. First, select your top five

unfinished quilt projects. Number them one through five, pinning the number to each. Bring a list of your FIVE UFOs to the AUGUST meeting and hand them to me, Ann Turley. Beginning with our AUGUST meeting, I will randomly select a number and announce it to the guild. You will have TWO MONTHS to complete that particular UFO and bring it to the OCTOBER meeting for show & tell. In OCTOBER, I will draw another number and you will have two months to complete that quilt. IF you have other UFO's, bring those to the UFO show & tell meeting. Each time you complete the specified UFO, your name goes into the box twice. If you complete additional UFOs along the way and you bring them for UFO show & tell, your name goes into the box once. At our final UFO show & tell, when all the names are in the box, I will draw for prizes! So here's the recap:

AUGUST-bring your list of UFOS and turn them over to Ann. The first number will be drawn. Finish and bring this quilt to UFO Show & Tell in OCTOBER.

OCTOBER – Another number drawn; quilt to be finished and revealed in DECEMBER.

DECEMBER – Another number drawn; quilt to be finished and revealed in FEBRUARY.

FEBRUARY – Another number drawn; quilt to be finished and revealed in APRIL.

APRIL – Last number drawn; quilt finished and revealed in JUNE during our annual potluck. Winning names will be drawn and prizes will be awarded!

# Minutes of Fallbrook Quilt Guild/ Committee Chair Executive Board

Call to order: An Executive Board/Committee Chair Meeting of the F.Q.G. was held at the Quilter's Cottage, in Fallbrook CA. The meeting was convened at 10:10 a.m. Presiding was President, Sharon Baker. Members present were: Sharon Baker, Anne Turley, Marie Sundsboe, Christy Smith, Anne Harris, Diana Rash, Linda Musillami, Carol Carpenter, Jan Conklin, Sandy Scott, Linda Flynn, JoAnne Russell, Susie Alderson and Sylvia Williams.

Items discussed:

Previous Minutes: Approved

Articles of Incorporation: Articles of Incorporation were given to Executive Board for inclusion in each separate guild executive position folder. This document packet also included a copy of the Guild's IRS federal tax exemption under section 509 (a) (2), California Franchise Tax Board Tax Exempt Determination Letter, and the State of California Department of Justice Nonprofit Raffle Registration Confirmation valid from 09/01/2013 through 08/31/2014.

Requirements include a minimum of an annual meeting of board officers who make decisions in good faith with minutes of meetings published for general membership. Marie will consult with attorney for compliance with tax exempt status. Cost of attorney consult will be approximately \$500.00. When Marie receives document from attorney, she will route to executive board.

Treasurer's Report: Remaining receipts pending for 2013-2014 have been received and the audit can proceed. Bills for Community Center rent and insurance through the Southern California Quilt Guild have been received and will be paid. 1099 forms for speakers given to Anne Turley.

Suggestion was made to change banks from Cal Western Bank for greater convenience and accessibility. Motion made by Linda Musillami to change banks, seconded by Susie Alderson. Motion passed. Discussion was held by executive board as to which banks might work well with Chase Bank and Wells Fargo as choices. Motion made by JoAnne Russell to use Chase Bank as the Guild's bank, seconded by Linda Musillami. Motion passed. Certified copy of Authorization to Change Banks/Account signed by Anne Turley and Diana Rash.

Budget: Each board member or committee that spends money should determine budget needs for the year and submit a budget request to the Treasurer. The current budget will be emailed to Christy for publication in the newsletter on a quarterly basis. Additional requests needed outside of the budget need to be submitted on a reimbursement form for approval PRIOR to making a purchase.

2014 Philosophy: Share information, stay within budget, quality not quantity.

Block of the Month: Susie and Jan suggested allowing members who do not make blocks to pay for a raffle ticket. BOM committee will solicit BOM ideas from members. BOM committee may need a budget if prepping materials.

Newsletter: Submit by 15th of the month with publication by the 25th. New newsletter format using "Pages" looks great! Thanks, Christy.

Ways and Means Committee: Committee will write an article for the newsletter to explain policy regarding selling tickets including venue sales and individual sales. Raffle scheduled for next General Meeting. Anne Harris suggested that the Guild purchase a new quilt stand for the Opportunity Quilt that would stay with the Ways and Means committee. Cost approximately \$130.00. Fees for Hot Summer Nights (\$25/night=\$100) and SD Quilt Show (\$10.00) have also been paid. Motion made by Anne Turley to approve budget request for \$130.00 for new stand and \$110.00 for fees, seconded by Marie Sundsboe. Motion passed. \$350.00 proceeds from 2014-2015 raffle sales at meeting,

UFO Project: Anne Turley discussed UFO project. She will write an article for newsletter to explain project.

Membership: 66 members signed in, 4 guests, 51 paid dues

### General Meeting Suggestions:

Time Management: Limit sharing to two items. During business reports, show/display any items available for raffle (e.g. BOM, Cup and a Quarter, 1-2 door prizes).

Room Set-up: Change slightly with chairs closer to stage and aisles narrower (not between rows).

Next Executive Board Meeting: Friday, August 8, 2014 at 10:00 a.m. at the Quilter's Cottage, Fallbrook., CA

# BLOCK OF THE MONTH

Block of the Month has traditionally been a way for less experienced quilters to try new things, to learn new techniques, and to have some fun - one block at a time! We will keep with that tradition and offer an opportunity to our ladies to try different block styles. But we also know that there are several of you who wouldn't mind picking up those

already made blocks for a fun and quick quilt project! So here's how BOM will work this year.

- 1. Each month we'll pick a quilt block pattern. We'll have a sample, a picture and instructions at the table at the guild meeting. We will also put the picture and instructions on the website.
- 2. You can pay \$1 for a pre-cut block kit at the meeting. Finish your block and bring it back the next month and submit it.
- 3. You can build a 'coordinating' block from your own stash fabric and bring it the next month and submit
- it. Since you used your own fabric, you will get two tickets for \$1 and be entered to win all the blocks.
- 4. And... even if you didn't make a block at all, you can NOW buy a ticket for \$1 and have a chance to win all those cute blocks!

We think that this will be a fun way for folks to try new things, but also for folks to build from home, and to participate even if you didn't make the block. We know that folks who use their own fabric won't 'exactly match' ours, but we think that scrappy is good too - and it will be fun to see what all that creativity out there comes up with!

Even though we didn't have this set up last month, you can still go to the website and check out the current block! It is 3-D, red, white and blue and lots of fun - and much easier to make than it looks! Make it up and bring it with you next month!

If you have some fun fabric that you want to donate we'll take it, or a fun and mostly simple pattern. Mostly we're looking to you to participate and help build individual blocks then watch them transform into a quilt!

# Instructions for making the Block Of The Month for July: (out of any Red, White and Blue Fabric)

- 1. Cut (4) 2.5" red squares
- 2. Cut (4) 2.5" white squares
- 3. Lay one red square on white square RST (right sides together)
- 4. Sew 1/4" on two sides (pivot, or sew separate seams but you are making a point)
- 5. Snip top of corner seam
- 6. Turn right sides out
- 7. Press flat with inside seam "changing direction" at the point
- 8. Repeat steps 3-7 three more times you now have 4 pinwheels
- 9. Cut (4) 4.5" blue squares
- 10. Pin one pinwheel edge to edge on one blue square
- 11. Repeat step 10 three more times
- 12. Sew the squares together to form the pinwheel.
- 13. The red and white "points" should be able to move up and down in the seam allowance. Finished block should measure 8.5" edge to edge.

You may also obtain additional tickets from any member of the Ways and Means Committee. It is your choice if you purchase the tickets personally or sell them to friends or family. This money and tickets may be turned in anytime at the monthly guild meeting. We need to have tickets sales finalized by the May guild meeting in 2015 to assure we are ready for the raffle drawing in June. Remember, a smaller version of "Ants on Parade" may be yours as your reward for selling the most tickets. Thank you from all of us.

### NON-PROFIT EXEMPT STATUS

On the IRS webpage you can confirm we were a tax-exempt charity and donations to the Guild are tax deductible. That means quilts donated to the Quilt Show, gifts to the monthly drawing, and other monetary and non-monetary donations qualify as a tax deduction. So, if you don't want to submit a claim for reimbursement and would rather get the tax credit, ask the Treasurer for the form for your tax records. Regarding charitable deductions used when filing your taxes, always consult your tax professional.

#### **BUDGET**

The annual audit and reconciliation is complete and the Guild is very solvent. Because of strict government requirements accurate and consistent record keeping is crucial. In order to make smooth fiscal transitions year after year and maintain consistency in record keeping, the following guidelines have been established:

- 1. All Committee chairs will be informed of the budget amount for their committee and are responsible for staying within that budget.
- The chair does not need the approval of the Board if the expenditure is within their budget.
- b. If the chair is unsure of how much funding they have available they should consult with the treasurer.
- c. If the committee chair feels funding beyond the original budgeted amount is required, the chair must present a request to the Executive Board for approval. A written request is not required as the request and subsequent discussion will be entered into the minutes.
- i. The Board is responsible for ensuring the Guild has sufficient funds to grant the request and the expense is justified.
- 2. Obtain approval from the committee chair before making any purchases on behalf of the Guild.
- 3. There must be a separate request for reimbursement for funds coming out of more than one fund. (Example: You buy cups for Hospitality and you purchase thread for the opportunity quilt. Complete two requests. One for hospitality with the Hospitality Chair's approval and another for the opportunity quilt with that chair's approval). You will be issued two separate checks.

This may seem a bit much, but it makes reconciliation so much easier – and the treasurer's job easier.
